Liberty County ESD 3 Meeting Minutes 10/08/2020

Meeting called to order at 7:01 PM

Pledge

Roll Call – Jeff LeBlanc, Lin Pruitt, Len Jones, Denny Loonam present and quorum is established. Bob Johns was ill.

Public Comment

There were no public comments

Minutes Report:

Jeff LeBlanc read the minutes from the meeting on September 10, 2020. Lin Pruitt motions to accept, Len Jones seconded. Motions passes without objection. Denny Loonam also added the minutes from the tax rate meeting. Motion to accept additional information by Len Jones, seconded by Jeff LeBlanc, passes without objection.

Treasurer Report:

Len Jones read the treasurer report.

Len added that as of today he did transfer \$15,000.00 from the sales tax account into the operating account Jeff LeBlanc motions to accept Treasurer Report. Lin Pruitt seconds, passes without objection.

Len Jones also added the monthly ad valorem tax report for 2019-2020.

Chief's Report

Caleb Anderson gave a copy of the bank statement of the department.

He noted an accidental charge of \$8.99, he did reimburse the dept.

Training coming up Mont Belvieu 10/24/2020 – 8 AM

The Bunker gear is in. Invoice should be coming in.

Kentwood's purchased with some monies left.

The fire dept will be holding a Halloween parade.

Discussion that the engine needed to be looked, pump needs to be recertified, and primer looked at.

The first quarterly payment needs to be paid to the department.

The final audit for the dept will be given in November.

\$1,6900.44, with the \$10.00 added back from the incorrect card swipe it is \$1,700.44, end of the year balance.

They will be buying a new ID machine.

Jeff LeBlanc suggested they order the machine before they report a final balance.

Lin Pruitt motions to accept the chief's report, Len Jones seconded, passed without objection

Old Business:

Bunker gear is there

Public Service Campaign is still ongoing. Current pricing mentioned seemed high of about \$5.00 a piece.

Change out agreement with Westlake is complete.

Jetta will look into getting grants for insurances and Anglia has offered to help.

There was a question on the amount paid to the insurance company twice. Len will look back into it.

New Business:

Discuss and take action on a sign for the fire department

Len Jones stated that we've been spending high and this should wait. Len Jones motions to table, Jeff LeBlanc seconds, passes without objection

Discuss mutual aid contract with Liberty County

We secured \$15,000.00. which is less than the other ESD's. Original offer was \$5,000.00 Settled at \$15,000.00. We stated we expect equal treatment next year.

Discuss and take action of replacing light bars on the booster and tanker:

Approximate cost is \$2,200.00

Caleb mentioned the older the trucks get the harder it becomes to find replacement parts.

Jeff LeBlanc clarified if this was a need now. Was informed yes.

Lin Pruitt warns of spending. But, was discussed this was a need.

Jeff motions up to \$2,200.00 for lights. Lin Pruitt seconds, passes without objection.

Discuss and take action in getting old gear recertified, cleaned and re-lettered.

Approximate cost per set \$119.60. We have 9 sets.

Jeff LeBlanc motions up to \$1,200.00 to achieve this. Lin Pruitt seconds, passes without objection.

Discuss and take action on hiring JR Ungles as an ESD inspector.

JR does have a class still left to take.

Discussion on looking into codes and we'd need an inspector.

JR discussed the code enforcement class and stated only 4 classes the rest of this year. He stated it runs \$500.00

Additionally, there is a filing fee

Denny clarified it would be about \$1,000.00 if JR took it and passed, we would reimburse.

JR mentioned we could possibly get a grant reimbursement.

Jeff Leblanc clarified this would be a paid position.

Lin Pruitt motions. Jeff LeBlanc seconds, passes without objection

Discuss and take action on a first responder vehicle:

Caleb asked us to hold off as they are looking into other options. Discussion was had about taking a loan. Was stated that the mutual aid contract would cover it. However, Len mentioned that puts us carrying debt again.

Caleb clarified this was a move to reduce personal vehicles on scenes.

Jeff LeBlanc questioned if this was a need.

Caleb was told to look into the options he currently is.

Jeff LeBlanc motions to table. Lin Pruitt seconds, passes without objection.

Motion to Adjourn:

Lin motions.

Reminder raised we needed to pay the fire department first quarter.

Lin asked if we could hold off until this month's tax payment came in.

Len Jones stated he could give them \$5,000.00 for now and the rest when the tax payment comes in.

Caleb agreed

Lin motions to split the payment, Jeff LeBlanc seconds. Passes without objection.

Jeff LeBlanc seconds original adjournment.
